 - Game Day will follow the same rule as other competitions so far as JV members competing as Varsity (JV members cannot swing up to a Varsity competition team more than twice)
 - Discussion about the rule
 - Christine makes motion, Natalie seconds; motion passes (22-1-0)
 - Add verbiage to by-laws about GameDay that it follows the same OSAA rules as other "traditional" cheer competitions (including stunt groups, individuals, full team, etc.).
